### **AGM Corporate Governance Checklist**

The Securities Commission Malaysia (**SC**) had, on 5 February 2020, released an Annual General Meetings Corporate Governance Checklist (**Checklist**), which is meant to serve as a general guide to shareholders for participation at an annual general meeting (**AGM**).

The Checklist highlights questions for shareholders to consider prior to, at and after the AGM. The questions set out in the Checklist are based on requirements relating to corporate governance prescribed in, among others, the 2016 Companies Act, the Malaysian Corporate Governance Code 2018 and Bursa Malaysia Listing Requirements.

An AGM is a platform which allows shareholders to raise questions, issues and seek clarification from the board and senior management. The Checklist is a useful reference for shareholders and is intended to promote accountability and aims to strengthen the overall corporate governance ecosystem.

While the Checklist was developed for shareholders, the SC has also encouraged other stakeholders, such as consumers and potential investors, to adopt the Checklist to understand and evaluate performances of companies.
